

INSTRUCTION TO THE TENDERERS

1. Tender must be addressed to the undersigned by name and will be received upto 26/07/2018 at 3.00 P.M. It will be opened on the same day at 3.30 P.M. in the presence of Tenderers who would be present at the time of opening.
2. The word Tender for purchase of Wooden Scrap and Plastic Scrap to be opened at 3.30 P.M. on 26/07/2018 should be super scribed on the envelop containing the Tender.
3. Material will be disposed "As is where is basis."
4. The validity of the offer should remain operative for 60 days from the date of opening the Tender for finalization of the same.
5. The Manager reserve the right to cancel any or all the tenders without assigning any reason.
6. **The tender should be accompanies by EMD of Rs.3000/- for the said material. The EMD must be in form of Demand Draft/Fixed Deposit /Banker Cheque in Favour of the "Pay and Accounts Officer(Ptg.), Ministry of Housing and Urban Affairs, New Delhi**
7. Earnest Money will be forfeited by the Govt. in full if the Tenderers resile from the offer within a period of 60 days from the date of opening of Tender.
8. Copy of PAN number and GST number must be submitted with the tender.
9. Deliveries of the stores are required to be taken of full payment to the Press within a period as specified in work order
10. Carrying arrangement with Labourers and transportation of stores will have to be borne by the Tenderers.
11. Rate to be furnished in quintal basis only. (In figure & in words.)
12. Sorting is not allowed.
13. The quantity mentioned in the Notice inviting Tender is approximate.
14. The Tender should be submitted in 2 BID SYSTEM (in bold letters) in separate double sealed covers one containing E.M.D. in proper form and other containing PRICE BID. Both the covers have to be super scribed with Tender No. , Its date of opening, Name of the Tenderers. These two covers should be put in one main sealed cover which should also be super scribed with Tender No., opening date and name of the Tenderer. In case the envelop /cover containing E.M.D not in proper form then the envelop containing PRICE BID will not be opened at all and that offer will automatically stand rejected.
15. The tenderer should quote PAN (permanent Account Number) in their tender. The tender will not be entertained without PAN.
16. The successful bidders shall lift the entire material lying in the press within 10 days from the issue of of Work order.
17. GST as applicable on the date of invoice will be payable by the buyer and GST must be quoted separately.
