Sealed Tenders are invited for disposal of used Aluminium Plates on the following terms and conditions.

1. Tender should be accompanied with EMD for Rs. 10,000/- in the form of Demand Draft from any Nationalised/Scheduled Bank duly pledged in favour of "The Pay & Accounts Officer (Ptg.), M/o HUA." payable at Nashik.
2. The rate should be quoted per Kg for the articles. The same should be written in figures and words without scoring / overwriting.
3. The used Aluminium Plates will be sold on "AS IS WHERE IS BASIS".
4. The approximate quantity of the material 1500 Kg
5. The envelope should be Superscribed "**Tender for disposal of Aluminium Plates due on 26/04/2018**" and should be addressed to The General Manager, Govt. of India Press, Nashik-6, so as to reach him on or before 25/04/2018 by 3.00 p.m. The tenders will be opened on the same day at 4.00 p.m. in the presence of Tenderers or authorised representatives of the firms.
6. The successful firm will have to furnish Security Deposit for Rs. 20,000/- (Rupees Twenty Thousand Only) in the form of Demand Draft in favour of The Pay & Account Officer (Ptg.), M/o HUA, payable at Nashik.
7. The bidder will have to furnish Permanent Account Number (PAN)/GST No.
8. The bidder will have to submit their work profile in respect of work/service rendered in other Government department in the past.
9. The material will be available for inspection on any working day during normal working hours of this Press (i.e. between 10.00 a.m. to 4.00 p.m.)
10. The taxes if levied by the Maharashtra Govt. on the sale will be payable in addition at any future date.
11. The successful Tenderer shall make his own arrangement for bags, boxes, vehicle, weightment and labourers that may be required for such removal during working days except Saturday, Sunday and Holidays.
12. The material in every respect shall remain at the risk of the Contractor from the date of acceptance of his offer by the General Manager and the office shall not be under any liability for the safe custody or preservation thereof from that date.
13. If the Tenderer withdraws from the offer or fail to lift the material within stipulated date and time the Earnest Money will be forfeited to the Government Account.
14. The General Manager, Govt, of India Press, Nashik-6 reserve the right to accept or reject the highest bid, any or all tenders/offers without assigning any reasons thereof.
15. The Tenderer should maintain peace and discipline in the Press Premises at the time of Lifting the material or else suitable action as deemed fit will be taken against the firm by this office.
