6. If rates are for articles of different specifications, the same may also be mentioned in each case.
7. Name of manufacturing firm and country of origin should be mentioned in each case.
8. The offer should be kept valid for 120 days from the date opening the tender.
9. The bidder will have to submit their work profile in respect of work/service rendered in other Government department in the past.
