Note: Eligibility criteria of empanment for A-Class Offset Printers (Annexure-I), B-Class Offset Printers (Annexure-II) and Digital Printers (Annexure-III) alongwith Guidelines may be referred and documents (hard copy & soft copy) must be attached accordingly.

Guidelines for empanelment of Private Offset Printers & Digital Printers with Directorate of Printing.

Documents required with the form of Application of Enlistment:

01. Name & address of the firm alongwith supporting documents i.e. Electricity bill, landline Telephone bill in the name of firm.
02. The list of machines and equipments installed including make year & model with their purchase bills in the name of the Press.
03. The Press should have average printing turnover for last three years as under:-
 - (a) A-Class Offset Printer – Rs. 7 crores.
 - (b) B-Class Offset Printer – Rs. 4 crores.
 - (c) Digital Printer – Rs. 1 crores.(The turnover should be certified by a Chartered Accountant).
04. Annual Income Tax Return for the last three years, alongwith balance sheet, Profit & Loss account.
05. The documents with regard to Local Sales Tax (LST), Central Sales Tax (CST) and VAT/GST etc.
06. All Risks' Insurance Policy:
 - (a) A-Class Offset Printers - Rs. 50,00,000/- and above which should cover the risks i.e. riots, fire, strike, theft, house-breaking, flood and burglary.
 - (b) B-Class Offset Printers - Rs. 25,00,000/- and above which should cover the risks i.e. riots, fire, strike, theft, house-breaking, flood and burglary.
 - (c) Digital Printers – Rs. 10,00,000/- and above which should cover the risks i.e. riots, fire, strike, theft, house-breaking, flood and burglary.
07. Police Declaration from respective authority.
08.
 - (a) The ownership documents, in case the firm is a Proprietorship concern, or if the premises are on rent/lease, the copy of registered agreement for a period of minimum 5 years shall be submitted.
 - (b) The Partnership Deed, in case the firm is a Partnership concern.
 - (c) The Memorandum and Articles of Association, in case the firm is a Pvt. Ltd. or Ltd.
09. Copies of documents mentioned at serial No. 8 from (a) to (c) (whichever is applicable) to be submitted alongwith Application for Empanelment.
10. Copy of a valid Registration certificate under Factory Act of the Press actually located.
11. Copy of Registration certificate under Company Act (if applicable).
12. Pollution clearance certificate/NOC from respective authorities.
13. The employees of the Private Printing Press should be covered with ESI Act, PF & other statutory requirements.
14. Undertaking that the Printing Press is not situated in residential area.
15. The Printers should have one complete unit i.e. pre-press, printing and binding alongwith paper storage facilities under one roof excluding composing/designing facility if any, failing which the proposal shall be summarily rejected.
16. Some printed samples of jobs executed by the Press during last 12 months alongwith list of Clients.
17. The Printer will submit an affidavit/certificate to the effect that the information submitted by him is correct and he will abide by the decision of Directorate of Printing in toto regarding empanelment. In the event of the information submitted by him is found to be false or fabricated in any manner whatsoever, they may be suspended and/or debarred from empanelment.

18. The application will be scrutinized and physical inspection of machine and equipments will be done, by the team of Officers. Thereafter, on approval of the competent authority the empanelment will be finalized subject to submitting the Security Deposit (in the form of FD valid for 3 years) as mentioned below:-
 - (a) A-Class Printer – Rs. 50,000/-.
 - (b) B-Class Printer – Rs. 30,000/-.
 - (c) Digital Printer – Rs. 20,000/-
19. The Offset Printers found eligible for empanelment will be classified into A & B category on the basis of their machines, equipments and performance.
20. Affidavit that the firm has never been black listed by any Government Department, Ministry, Organization /PSUs etc. in last 5 years.
21. Directorate of Printing shall have the right to reject any or all applications for empanelment without assigning any reason thereof.
22. Jurisdiction – All disputes subject to the jurisdiction at Delhi Courts only.
23. Arbitration – In case of any dispute the matter will be referred to the Arbitration appointed by Directorate of Printing.
24. In absence of the requisite documents, the proposal will be outrightly rejected and no further communication will be entertained.
25. **Empanelment shall remain valid for three years and can be extended (in absence of fresh empanelment) for another 2 years on yearly basis.**
26. The Empanelment can be cancelled at any time by Directorate of Printing and no correspondence will be entertained.
